

THE BIG IDEA | A SMALL BUSINESS GRANT

What do Facebook, DreamWorks, PayPal, and Apple have in common? Each was founded or co-founded by someone from the LGBTQ community. With an estimated 1.6 million LGBTQ-owned businesses in the U.S., it's not surprising that LGBTQ people have built some of the most successful companies on earth. That being said, everyone must start somewhere.

We know that things have been tough on businesses big and small, and because of these circumstances, you may be putting off one of your big ideas to bring your business to the next level. If you were given \$5,000 to improve your business, how would you spend it? Now's your chance to bring your big idea to fruition.

"The Big Idea", a Small Business Grant Sponsored by GLCCNV and Cox Business, offers financial assistance to get your big idea off the ground. The financial award is intended to help a current or future small business owner (who is also a member of the GLCCNV) with an investment in their business and facilitating bringing their big idea to fruition.

One \$5,000 grant is available for the best "Big Idea". The winner will be announced in Q3 2022, and will be awarded in check form, made payable to the business.* Statewide applications will be reviewed by a panel of members from the Chamber, Cox Business, Cox Diversity Council, and respected business leaders.

In addition to the financial award, the recipient will receive mentoring from GLCCNV President Tim Haughinberry, prominent leaders within Nevada's LGBTQ+ business community and Cox Business. Having someone to listen, share experiences, and pass-on knowledge is a privilege for our mentors and an invaluable tool for new business owners.

"The Big Idea", An Entrepreneurial Grant Sponsored by GLCCNV and Cox Business, considers many factors when assessing applicants, including:

- A proven track record of leadership and community involvement
- Strong academic and/or work experience
- An entrepreneurial spirit
- Working for the betterment of the LGBTQ+ community
- "Out" as a person who identifies as LGBTQ+
- A full-time resident of the State of Nevada (minimum two years)
- Intent to use funds toward the start-up costs of a local business or as an infusion to an existing business with a panel approved business plan
- Financial need
